4 A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE  
5 VILLAGE OF PALMETTO BAY, FLORIDA, IN SUPPORT OF THE  
6 HOLIDAY RUN EVENT; PROVIDING FUNDING SUPPORT FOR THE  
7 2007 EVENT; AUTHORIZING THE VILLAGE MANAGER TO  
8 ALLOCATE AN AMOUNT NOT TO EXCEED \$4,000 FOR THE EVENT  
9 HELD ANNUALLY WITHIN THE VILLAGE OF PALMETTO BAY; AND  
10 PROVIDING AN EFFECTIVE DATE. (Sponsored by Council member  
11 Stanczyk)

12 **WHEREAS**, the annual Holiday Run 5K/15K to be held this year on December 8,  
13 2007, has historically been an extremely successful and has been welcomed by the Village  
14 Council and residents; and

15 **WHEREAS**, PR Racing, Inc., has requested a partnership with the village to assist with  
16 the production of this worthwhile event; and,

17 **WHEREAS**, the village feels this is an important and desirable event to the Palmetto  
18 Bay community; and,

19 **WHEREAS**, the village wishes to support the 2007 event by providing funding  
20 assistance in an amount not to exceed \$4,000 in the form of in-kind services and costs defrayals.

21 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE  
22 COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

23 **Section 1:** The Village Council approves funding assistance for the 2007 Holiday  
24 Run held in Palmetto Bay.

25 **Section 2:** The Village Manager is hereby authorized to allocate an amount not to  
26 exceed \$4,000 for the 2007 event in the form of in-kind services provided  
27 by the Village and costs defrayals.

28 **Section 3:** This resolution shall take effect immediately upon adoption.




