Public Record Request(s): Examination of notifications to homeowners along SW 136 Street of the plans for the upcoming installation of a multiuse path and resurfacing project on SW 136th Street from Old Cutler Road to US-1., included in this is notification relative to both the plans itself as well as the public meeting of 1/28/2020.

Florida Supreme Court Tribune Company v. Cannella 458 So. 2d 1075 (Fla. 1984).
