(1) Please provide me with a copy of the Sacyr Franjo Project contract with amendments (change orders authorized/pending). *See Attachments.*

(2) If possible, please give me the "amount already paid currently" to Sacyr Construction for the Franjo Project. (or do I have to request "all Sacyr invoices paid"... and add the totals myself from them?)

Total Disbursed \$ 8,659,783.53*

Why hasn't anyone on the Council already requested the information and "already know" the answers to my concerns about the costs and time frames of the Sacyr project???
