Honorable Mayor and Council Members

I am writing in behalf of the Golf Carting community which number over 700 at present.
We would like for you to consider a few changes to the Golf Cart regulations here in Palmetto Bay to be more in line with the ones in Cutler Bay. Also included are several suggestions to keep in mind for improvements to the use of golf carts in the Village.

1. Allow the use of County roads for use of Golf Carts as per updated Florida Statutes 316.212(1). Except for Old Cutler

Road.

2. Allow the use of the Village bridges so we can reach all parts of the village. Currently, because all the canals and prohibited streets, we can only go to certain areas because of the segmentation of the Village due to the canals and prohibited streets. For instance I live near Councilwoman Matson and cannot go the People's Dock.

3. Allow Golf Carts the use of the Old Cutler Pathway

4. Widen the obstructions to allow golf carts to traverse the Chinese Bridge Road as an alternative to Old Cutler Rd.

5. Include provisions for golf carts in the walkway/pathway widening program.

6. Include golf cart pathways on to Snowden Bridge renovation project to cross the C100 canal.

7. Build golf cart / pedestrian bridges on 77 and 87 Avenues to cross the canals.

8. Install golf cart charging stations and parking in public facilities. I hopefully expect you would

9. review our recommendations and implement them as soon as you possibly can.
