3 **A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL**
4 **OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATED**
5 **TO PROCUREMENT; APPROVING THE SELECTION OF H &**
6 **R PAVING, INC. TO PROVIDE ROADWAY RESURFACING**
7 **SERVICES PURSUANT TO INVITATION TO BID (ITB) NO.**
8 **1920-11-001; AUTHORIZING THE INTERIM VILLAGE**
9 **MANAGER TO ENTER INTO AN AGREEMENT WITH SAID**
10 **COMPANY TO RESURFACE TWELVE (12) PRIORITIZED**
11 **STREET LOCATIONS FOR THE AMOUNT OF \$170,204.84**
12 **AND OTHER LOCATIONS THROUGHOUT THE VILLAGE AS**
13 **NECESSARY FOR A TOTAL COST FOR ROADWAY**
14 **RESURFACING NOT TO EXCEED \$350,000; AND PROVIDING**
15 **FOR AN EFFECTIVE DATE. (Sponsored by Administration)**

17 **WHEREAS**, in order to keep the Village owned streets in good
18 operational order, the Public Service Department is tasked to inspect and
19 flag any roadway that is in need of repair with resident input and visual
20 inspections; and,
21

22 **WHEREAS**, funding in the amount of \$350,000 has been allocated
23 in fiscal year 2019-20 for street resurfacing, pavement markings, striping
24 placements and deletion of old pavement markings; and,

26 **WHEREAS**, a competitive bid process was followed for street
27 resurfacing with the issuance of an Invitation to Bid (ITB) No. 1920-11-
28 001 on October 24, 2019 to resurface twelve (12) prioritized areas
29 recommended by the Public Service Department; and,

31 **WHEREAS**, the ITB also requested itemized pricing for any
32 additional potential areas identified in the future; and,

34 **WHEREAS**, the Village received a total of two bids on December
35 11, 2019 and following the bid review, determined H & R Paving, Inc. to
36 be the lowest responsive and responsible bidder; and,

38 **WHEREAS**, the Village wishes to proceed with the selection of H.R.
39 Paving, Inc. to provide roadway resurfacing services pursuant to the
40 issued ITB.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:

Section 1. The Village Council hereby approves the selection of H.R. Paving, Inc. to resurface the twelve (12) prioritized street locations indicated on the ITB for the amount of \$170,204.84 as well as other future locations throughout the Village as necessary for a total cost for roadway resurfacing not to exceed \$350,000, and further authorizing the Interim Village Manager to sign the required agreement.

Section 2. This resolution shall become effective upon adoption.
