**RESOLUTION NO. 2012-54**

**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO AD VALOREM TAXES; ESTABLISHING THE PROPOSED MAXIMUM MILLAGE RATE AND SETTING THE DATES, TIMES AND LOCATION FOR THE FIRST AND SECOND BUDGET HEARINGS FOR FY 2012-2013; FURTHER DIRECTING THE VILLAGE CLERK TO FILE SAID RESOLUTION WITH THE MIAMI-DADE COUNTY PROPERTY APPRAISER; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Village has received the Certification of Taxable Value from the Miami-Dade County Property Appraiser; and,

**WHEREAS**, the Village is required under State Statutes to establish and furnish to the Property Appraiser the proposed maximum millage rate and the dates, times and location(s) at which public hearings will be held to consider the FY 2012-2013 millage rate and budget; and,

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:**

**Section 1.** The proposed maximum millage rate for the Village of Palmetto Bay for FY 2012-2013 is established at 2.447 mills, which is \$2.447 for each \$1,000.00 of assessed property within the Village of Palmetto Bay.

**Section 2.** The proposed date and place of the first and second public hearings are scheduled as follows:
