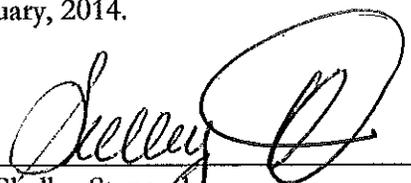
Section 1. Recitals. The above recitals are true and correct and incorporated herein by this reference.

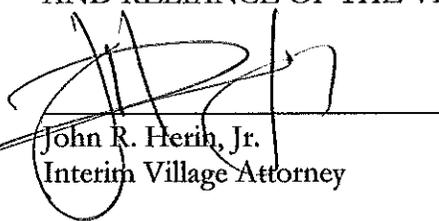
Section 3. Effective Date. This resolution shall take effect immediately upon approval.
