

RESOLUTION NO. 2014-79

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, CERTIFYING AND DECLARING THE RESULTS OF THE GENERAL ELECTION OF NOVEMBER 4, 2014, AND RUN-OFF ELECTION OF NOVEMBER 25, 2014; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the certification of the results of the General Election of November 4, 2014, has been delivered to the Council; and

WHEREAS, the certification of the results of the Run-Off Election of November 25, 2014, has been delivered to the Council; and

WHEREAS, the election has been canvassed; returns have been made by inspectors and the Supervisor of the Election; ballots of registered voters have been tabulated; and, a determination of the total number of votes cast at such election has been conducted.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA AS FOLLOWS:

Section 1. That the above and foregoing recitals are true and correct.

Section 2. That the Council hereby declares and certifies that at the General Election of November 4, 2014, and the following votes were cast as follows:

For Mayor, the whole number of votes cast was 8,175, of which number:

Peter England received 1,954 votes
Patrick Fiore received 1,663 votes
Eugene Flinn received 2,508 votes
Shelley Stanczyk received 2,050 votes

For Council Member – Seat 1, the whole number of votes cast was 7,790 of which number

Karyn Cunningham received 5,246 votes
David “Dave” Zisman received 2,544 votes

For Council Member – Seat 3, the whole number of votes cast was 7,336 of which number

Henry Clifford received 2,633 votes
Larissa Siegel Lara received 3,225 votes
James Archie Shedd received 1,478 votes

Section 4. That it is hereby certified and declared that the Charter of the Village of Palmetto Bay is not amended as noted above. Section 10.1 remains, as is.


