RESOLUTION NO. 2017-31

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AUTHORIZING THE DEPARTMENT OF PUBLIC SERVICES TO PURCHASE AND INSTALL STRICTLY ENFORCED VERTICAL PANELS ON VARIOUS SPEED LIMIT SIGN POST WITHIN THE VILLAGE; AND FURTHER ISSUE A PURCHASE IN AN AMOUNT NOT TO EXCEED \$7,500.00 TO UNIVERSAL SIGNS AND ACCESSORIES; AND PROVIDING FOR AN EFFECTIVE DATE. (Sponsored by Councilmember David Singer and Co-Sponsored by Mayor Eugene Flinn)

WHEREAS, The Village desires to implement additional traffic calming devices to further enforce speed limits within the boundaries of the Village; and

WHEREAS, "STRICTLY ENFORCED" signage attached to speed limit sign post is viewed to be an effective added resource to emphasize that speeders won't be tolerated on Village roadways. A photo example of the signage has been attached as Exhibit A; and

WHEREAS, 200 STRICTLY ENFORCED vertical panels will be attached to speed limit post at critical locations where speeding has been documented by the Village's Policing Unit; and

WHEREAS, once the "STRICTLY ENFORCED" vertical panels are installed law enforcement officers will proceed to strictly enforce speed limits as posted throughout the Village; and

WHEREAS, Universal Signs & Accessories is the only distributor in the State of Florida authorized to sale the Brite Side Panel product; and

WHEREAS, Universal Signs & Accessories has provided the Village with pricing in the amount of \$37.50 per panel. A copy of the quote is attached hereto as Exhibit B; and

WHEREAS, the strictly enforced signage will be funded from the Traffic Signals and Signs budget in an amount not to exceed \$7,500.00; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. The Village Council of the Village of Palmetto Bay hereby authorizes the Village Manager to issue a purchase order in an amount not to exceed \$7,500.00 to Universal Signs & Accessories for the purchase of "strictly enforced" vertical panels to attach to speed limit post at critical locations where speeding has been documented by the Village's Policing Unit.

1 **Section 2.** Once the strictly enforced vertical panels are installed law enforcement
2 officers will proceed to strictly enforce speed limits.


