Dear Ms. Pittser:

I am writing on behalf of Sacyr Construction USA LLC ("Sacyr"), one of the bidders for the Franjo Road Project (1617-11-003) (the "Project"), to request the immediate release of the final, tabulated scores and Price Sheets for each of the proposing teams for the Project. Pursuant to Section 3.04 of the Request for Proposals for the Project, all proposals were to "be opened and declared publicly." On Tuesday night, the Village Manager, after receipt of the presentation scores from the Village Councilmembers, read them privately, presumably performed the tabulation, and then announced his recommendation, which the Council subsequently ratified by resolution, all without providing the public, or the proposing teams, with the scoring to support his recommendation.

Sacyr and the other members of its team invested a lot of time, effort, and money in pursuit of the Project and deserve to know how they performed relative to their competition. Additionally, failure to release the tabulated scores and price sheets prevents the proposers from making an assessment as to whether the Village complied with its Code of Ordinances and the RFP in making its selection.
