A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO INTERNATIONAL WOMEN’S DAY; RECOGNIZING INTERNATIONAL WOMEN’S DAY ON MARCH 8, 2018 IN THE VILLAGE OF PALMETTO BAY WITH APPROPRIATE PROGRAMS AND ACTIVITIES; AND PROVIDING FOR AN EFFECTIVE DATE. (Sponsored by Councilmember Karyn Cunningham, and Co-Sponsored by Mayor Eugene Flinn, Vice Mayor John DuBois, Councilmember David Singer, and Councilmember Larissa Siegel Lara)

WHEREAS, the Village of Palmetto Bay is the proud home of many women deserving of recognition for their contributions to their homes, families and their community; and

WHEREAS, the Village Council seeks to recognize all women living and working in the Village, and women in the Nation and the World; and

WHEREAS, March 8, 2018, has been designated by the United Nations International Women’s Day, a global day celebrating the social, economic, cultural and political achievements of women. The day also marks a call to action for accelerating gender parity.

NOW, THEREFORE, BE IT RESOLVED, BY THE VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, AS FOLLOWS:

Section 1: The Village of Palmetto Bay will support the goals of International Women’s Day as follows:

- (a) Recognize that the empowerment of women is inextricably linked to the Village’s and the Nation’s potential growth and prosperity;
- (b) Recognize and honor individuals in the Village, the Nation, and around the world, that have worked throughout history to ensure that women are guaranteed equality and basic human rights;
- (c) Encourage the people of the Village of Palmetto Bay to observe International Women’s Day with appropriate programs and activities.
