RESOLUTION NO. 05-36

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA; RELATING TO PARKS AND RECREATION; AUTHORIZING THE VILLAGE MANAGER TO ENTER INTO AN AGREEMENT WITH PIAZZA, INC. TO PURCHASE MUCH NEEDED PARK AMENITIES FOR CORAL REEF PARK; DISBURSING AN AMOUNT NOT TO EXCEED \$64,234.40 FOR THE PURCHASE, DELIVERY AND INSTALLATION OF PARK BENCHES, PICNIC TABLES AND TRASH RECEPTACLES; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Coral Reef Park is a regional park facility expanding more than 50 acres;
and

WHEREAS, improvements to Coral Reef Park began in 2003, when the County ceded control to the Village, with overall grounds improvements and the revamping of the famous wooden bridge; and

WHEREAS, as we continue the renaissance of Coral Reef Park, Staff recommends the addition of necessary park amenities to include beautiful and sturdy park benches, picnic tables, bike racks, and trash/recycling receptacles that will contribute to a user-friendly park;
and

WHEREAS, the current inventory of park amenities compared to the number of users is extremely inadequate; and

WHEREAS, Staff has spent a considerable amount of time researching products to find materials that combine quality, durability and comfort while taking into consideration products that are unique, safe and continue to contribute to the beauty of Coral Reef Park; and

WHEREAS, Piazza Inc. is a reputable company with a long list of satisfied municipal clients who have an outstanding reputation for quality of product, competitive prices and excellence in customer service; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:


