I'm a local freelance journalist. Pursuant to Article I, section 24 of the Florida Constitution, and chapter 119, F.S., I am requesting an opportunity to inspect or obtain copies of public records of all documents regarding Palantir Technologies and any prior public records request regarding Palantir Technologies. The documents I request include, but are not limited to, paper, email, or otherwise electronic copies.

I request a waiver of all fees for this request since the disclosure of the information I seek is a journalistic endeavor and not primarily in my commercial interest, and is likely to contribute significantly to public understanding of the operations or activities of the government, making the disclosure a matter of public interest. The revelation of these records would help the the public understand how police conduct their business and keep police agencies accountable.

Should you deny my request, or any part of the request, please state in writing the basis for the denial, including the exact statutory citation authorizing the denial as required by s. 119.07(1)(d), F.S.
