No redaction of information collected is covered by the public records law exemptions. 2. a copy of ALL the email addresses used to send or are received in response to Eugene Flinn's South Dade Updates, the Flinn Flyer; contacts collected from the twitter account Eugene Flinn Palmetto Bay Mayor or collected from responses to his South Dade Updates blog site. This request

includes all those email addresses used to send, listed in contacts subscribers, submittals, followers, or contacts that subscribed, followed, or are followed by Eugene Flinn. under the titles: South Dade Updates, the Flinn Flyer, Eugene Flinn Facebook, Eugene Flinn Palmetto Bay Mayor Twitter account. No exemptions to this request is covered by the public records statute since these social media are linked to the Palmetto Bay Official Website. No redactions or alterations to remove, limit or make illegible should be done. The email addresses may be copied from inbox page and the sent page without alteration of the information, and the subscribers and contacts are accessed from the individual sites. The response to this request can be made electronically by email or upon notice of readiness copied to a new in the package memory stick. Please respond with a cost estimate. Since these items are not Village owned the cost for Mr. Flinn to prepare the responses should be nil.
