5 **A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF**
6 **THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO**
7 **AD VALOREM TAXES; ESTABLISHING THE PROPOSED**
8 **MAXIMUM MILLAGE RATE AND SETTING THE DATES,**
9 **TIMES AND LOCATION FOR THE FIRST AND SECOND**
10 **BUDGET HEARINGS FOR FY 2010-2011; FURTHER DIRECTING**
11 **THE VILLAGE CLERK TO FILE SAID RESOLUTION WITH**
12 **THE MIAMI-DADE COUNTY PROPERTY APPRAISER; AND**
13 **PROVIDING FOR AN EFFECTIVE DATE.**

15 **WHEREAS**, the Village of Palmetto Bay has received the Certification of Taxable Value
16 from the Miami-Dade County Property Appraiser; and,

18 **WHEREAS**, the Village is required under State Statutes to establish and furnish to the
19 Property Appraiser the proposed maximum millage rate and the dates, times and location(s) at
20 which public hearings will be held to consider the FY 2010-2011 millage rate and budget; and,

22 **NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE**
23 **COUNCIL OF THE VILLAGE OF PLAMETTO BAY, FLORIDA, AS FOLLOWS:**

25 **Section 1.** The proposed maximum millage rate for the Village of Palmetto Bay for
26 FY 2010-2011 is established at 2.544 mills, which is \$2.544 for each \$1,000.00 of assessed
27 property within the Village of Palmetto Bay.

29 **Section 2.** The rollback millage rate is 2.5442 mills.

31 **Section 3.** The proposed date and place of the first and second public hearings are
