RESOLUTION NO. 2014-28

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, URGING THE LEGISLATURE TO MAKE MODIFICATIONS TO THE CURRENT LAWS TO INSURE AFFORDABILITY OF HOMEOWNERS INSURANCE AND WINDSTORM INSURANCE AND INSURE FAIRNESS AS IT RELATES TO EXCESSIVE SURCHARGES; PROVIDING FOR CONFLICTING RESOLUTIONS; PROVIDING AN EFFECTIVE DATE. [Sponsored by Councilman Patrick Fiore and Mayor Shelley Stanczyk.]

WHEREAS, the Mayor and Village Council desire to establish their legislative agenda items and to express their concerns as to State legislative items; and,

WHEREAS, many residents of Palmetto Bay are facing increases in their windstorm insurance premiums and homeowners' insurance premiums; and

WHEREAS, the Village of Palmetto Bay urges the legislature to make modify current legislation to insure the affordability of these important insurance coverages; and

WHEREAS, the Village of Palmetto Bay additionally urges the legislature to modify current laws to insure fairness as it relates to excessive surcharges being billed to residents of Palmetto Bay; and

WHEREAS, the Mayor and Village Council of Palmetto Bay encourages modification of current laws to the current laws to insure affordability of homeowners insurance and windstorm insurance and insure fairness as it relates to excessive surcharges.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. The foregoing "Whereas" clauses are hereby ratified as true and correct and are incorporated herein by this reference.

Section 2. The Village Clerk shall provide executed copies of this resolution to the Village's lobbyist, and to the Florida Legislature, the Mayor of Miami-Dade County, each member of the Miami-Dade Board of County Commissioners, as well as each municipal clerk in Miami-Dade County for the purpose of distributing copies to members of their respective governing councils.


Section 3. This resolution shall be effective immediately upon its adoption.


