A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO SPECIAL EVENTS; SPONSORING THE 4TH ANNUAL DENITO'S RIDE FOR KIDS, AS A SIGNATURE SPONSOR; AUTHORIZING THE VILLAGE MANAGER TO DISBURSE FUNDS IN AN AMOUNT NOT TO EXCEED \$8,000.00 SPECIFICALLY DESIGNATED TO COVER THE COSTS OF OFF-DUTY POLICE AND PURCHASE OF SUITABLE BICYCLES, AS WELL AS USE OF THE VILLAGE LOGO ON ALL PROMOTIONAL MATERIAL; AND PROVIDING FOR AN EFFECTIVE DATE. BACKGROUND AND ANALYSIS:

DeNito's Ride for Kids, Inc., for the past few years, has focused on kids that are unable to ride bicycles due to mental or physical disabilities; embracing the belief that every child should be provided the opportunity to experience the enjoyment of bike riding. With that thought in mind, this organization annually conducts fund-raising events to generate funds with the primary purpose of working with bicycle manufacturers within the United States to produce safe, stable and stylish vehicles for use by children with lower levels of ability; but equally or higher enthusiasm to participate.

FISCAL/BUDGETARY IMPACT:

Funding to be allocated from the Special Events budget.

RECOMMENDATION:

It is recommended that the Village of Palmetto Bay, in recognition of this worthwhile project and desire to participate, become a Signature Sponsor; and further, donate funding in the amount not to exceed \$8000; to be designated for specific expenditures to cover the costs of Off-Duty Police and purchase of suitable bicycles.

WHEREAS, the Village of Palmetto Bay is grateful to DeNito's Ride for Kids and its service to our community for investing in those who are in need; and

WHEREAS, the Village of Palmetto Bay believes that supporting this event is a worthwhile endeavor which merits monetary support to offset operational costs.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:

Section 1. The Village Council hereby deems it to be in the Village's best interest to become a Signature Sponsor of the DeNito's Ride for Kids.

Section 2. The Village Manager is hereby authorized to provide Signature Sponsor monetary support in the form of a donation in the amount of \$8,000 to DeNito's Ride For Kids, Inc., with funding specifically designated to cover the cost of Off-Duty Police and purchase of suitable bicycles, as well as authorization to utilize the Village logo in all promotional material.

Section 3. This Resolution shall take effect immediately upon its passage and adoption.
