The following rules, if broken would result in ineligibility from the contest:

1. All talent show participants must report 1 hour in advance of Talent Show
2. Maximum 4 minutes per act (points will be deducted for acts going over allotted time) Acts going over 5 minutes will be automatically disqualified!!
3. Performers are responsible for bringing their own music, props and instruments. Make sure each item is appropriately labelled with student's name and school. *The Village of Palmetto Bay is not responsible for any equipment not retrieved after the event.*
4. No voice or voices or synthesized vocal utterance may be used for accompaniment by contestants entered in the Vocal categories. This includes recorded live voices and voices that are produced and recorded synthetically. (i.e. synthesizers or digitally sampled.)
5. In the Instrumental categories, live or taped accompaniment is allowed but must assume the pure character of accompaniment. The test shall be whether the performance would stand alone. The use of any instrument(s) being judged is not allowed. In the use of any electronic keyboard, no pre-programmed music is allowed; the contestant must create all sound live on stage.
6. Village of Palmetto Bay is not responsible for theft/damage or injury of any kind, to persons or instruments, props, clothing etc., during, before or after the performance.
7. Contestants are only allowed one entry in one category.
8. Organizers reserve the right of final decision on any matters pertaining to the event not covered by the rules.

3. I understand that I am financially liable for property damage caused by the Participant.
4. I waive all claims and release the Village of Palmetto Bay along with staff and volunteers, against any and all liability in respect to any loss or damage to my property, or the Participant's property, including any such loss or damage that is caused or contributed to by the negligence of Village of Palmetto Bay Park.
5. I waive all claims and release the Village of Palmetto Bay along with staff and volunteers from and against any and all liability in respect to personal injury or death to the Participant, except where such loss or damage is caused or contributed to by the Village of Palmetto Bay along with staff and volunteers negligence or by such other act or omission for which the Village of Palmetto Bay is legally responsible, and the case of such negligence or other act or omission.
6. I warrant to the Village of Palmetto Bay that the information on this Form (as well as the REGISTRATION FORM) is true, current and accurate and that I have read and understood all of its content.
7. If any clause in this document is held to be invalid or unenforceable, the remaining clauses continue in effect.
