

RESOLUTION NO. 04-10

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO ROADWAY AND SIDEWALK ANALYSIS WITHIN THE VILLAGE OF PALMETTO BAY: AUTHORIZING THE SELECTION OF CIVIL WORKS, INC., TO PROVIDE GENERAL ENGINEERING SERVICES TO THE VILLAGE IN THE AMOUNT OF \$34,800; AUTHORIZING THE VILLAGE MANAGER TO CONTRACT FOR THESE SERVICES IN THE STATED AMOUNT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of Palmetto Bay needs to determine the sidewalk locations and pavement condition within the right-of-ways owned by the Village, this analysis will be used to prepare a program for sidewalk and pavement maintenance; and

WHEREAS, the Village desires to identify where there are missing sidewalks and pedestrian ramps required to meet the American Disabilities Act (ADA); and

WHEREAS, the Administration has determined that Civil Works, Inc., is highly knowledgeable of the Village and is more than capable firm and was qualified by the selection committee to perform an analysis of this nature for the Village of Palmetto Bay; and

WHEREAS, the Administration desires to select Civil Works, Inc., to perform a roadway and sidewalk analysis report of existing pavement and sidewalk conditions within the Village;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO, BAY FLORIDA, AS FOLLOWS:

Section 1: The following firm is selected to provide General Engineering Services for the Village of Palmetto Bay.


Civil Works, Inc.
