

RESOLUTION NO. 05-10

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA; AUTHORIZING THE VILLAGE MANAGER TO ENTER INTO CONTRACT NEGOTIATIONS WITH THE ARCHITECTURAL AND ENGINEERING FIRM OF BERMELLO, AJAMIL & PARTNERS, INC. FOR THE DESIGN AND ENGINEERING OF PERRINE WAYSIDE PARK; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the process was a success and the Village of Palmetto Bay has adopted a Parks Master Plan for five of our park facilities; and

WHEREAS, a competitive bidding process preceded the adoption of Resolution 03-70 approving the selection of several outstanding firms for architectural work; and

WHEREAS, Bermello, Ajamil & Partners has successfully designed outstanding facilities for the cities of Miami, Coral Gables and Miami Beach as well as a beautiful recreation center and gymnasium for the City of Aventura; and




