A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO THE PURCHASE OF VEHICLES; AUTHORIZING THE VILLAGE MANAGER TO ISSUE PURCHASE ORDER FOR THE PURCHASE OF VEHICLES WITH ACCESSORIES FROM BLAKE CHEVROLET, IN THE AMOUNT OF \$52,800; PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Village would like to purchase additional vehicles from Blake Chevrolet to meet the level of service requirements of the various operating departments; and,

WHEREAS, the Village of Palmetto entered into a road transfer agreement with Miami-Dade County effective as January of 2005 for the maintenance of all roadways and right of ways within the Village with the exception of major arterial roads; and,

WHEREAS, the Village has acquired ownership of several new park facilities; and

WHEREAS, the Village would like to purchase trucks consistent with the current fleet purchased from Blake Chevrolet in FY2003; and

WHEREAS, Blake Chevrolet, has quoted pricing pursuant to General Motors Bid Assistant Program for the provision of these vehicles.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:



Section 2: This Resolution shall take effect immediately upon approval.


