RESOLUTION NO. 06-111

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO CONTRACTS; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE AN AGREEMENT WITH ENVIROWASTE SERVICES GROUP, INC., FOR CONTINUED STORM DRAINING CLEANING WITHIN THE VILLAGE OF PALMETTO BAY; AUTHORIZING THE VILLAGE MANAGER TO ISSUE A PURCHASE ORDER IN AN AMOUNT NOT TO EXCEED \$75,000.00; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of Palmetto Bay requires a contractor to perform storm drain cleaning within the Village; and,

WHEREAS, the Village of Pinecrest has contracted with EnviroWaste Services Group, Inc. for the jet cleaning of catch basins, French drains and connecting pipes pursuant to their response to a request for proposals; and,

WHEREAS, pursuant to the Village's purchasing procedures, the Village may enter into contracts for services with contractors without following competitive bidding procedures when another public agency has already followed proper formal bid procedures; and,

WHEREAS, the Village would like to "piggyback" the contract between EnviroWaste Services Group, Inc. and the Village of Pinecrest; and,

WHEREAS, EnviroWaste Services Group, Inc. has agreed to provide the necessary services and resources to the Village utilizing the same pricing, terms and conditions as set forth in Agreement with the Village of Pinecrest dated the 1st day of November , 2006; and,

WHEREAS, Envirowaste Services, Group, Inc. completed storm drain cleaning services within the Village in Fiscal Year 2005-2006, in the amount of \$30,000 for storm drain cleaning services; and,

WHEREAS, the Village of Palmetto Bay has budgeted \$75,000 to continue cleaning existing storm drain inlets within the Village during Fiscal Year 2006-2007; and,

6 **Section 1:** The Village Manager is authorized to “piggy back” on the Village of
7 Pinecrest storm drainage cleaning services contract with EnviroWaste Services Group,
8 Inc., and is authorized to execute a purchase order in an amount not to exceed \$75,000
9 for storm drain cleaning to the approved vendor under the terms and conditions set forth
10 in the agreement with the Village of Pinecrest.
