A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO CONTRACTS; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE AN AGREEMENT WITH METRO EXPRESS, INC. FOR NEW SIDEWALKS AND REPAIR OF EXISTING SIDEWALKS AND CURBING WITHIN THE VILLAGE OF PALMETTO BAY; AUTHORIZING THE VILLAGE MANAGER TO ISSUE A PURCHASE ORDER IN AN AMOUNT NOT TO EXCEED \$125,000.00; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of Palmetto Bay requires a contractor to construct new sidewalks and continue repairing existing sidewalks and curbing throughout the village on an as needed basis; and,

WHEREAS, Miami-Dade County has contracted with Metro Express, Inc. for sidewalk construction pursuant to its response to a request for proposals; and,

WHEREAS, pursuant to the village's purchasing procedures, the village may enter into contracts for services with contractors when another public agency has already followed proper formal bid procedures; and,

WHEREAS, the village would like to "piggyback" the contract between Metro Express, Inc. and Miami-Dade County; and,

WHEREAS, Metro Express, Inc. has agreed to provide the necessary services and resources to the village utilizing the same pricing, terms and conditions as set forth in the Agreement with Miami-Dade County dated the 25th day of April, 2006; and,

WHEREAS, Metro Express, Inc. completed sidewalk and curbing repairs within the Village in Fiscal Year 2005-2006, the Village expended approximately \$75,000 for new sidewalk and repair of existing sidewalk and curbing; and,

WHEREAS, the Village of Palmetto Bay has budgeted \$125,000 to install new, repair existing sidewalk and add curbing in Fiscal Year 2006-2007.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:


1 **Section 1:** The Village Manager is authorized to piggyback on the Miami-Dade
2 County contract document entitled: GOB Sidewalk Contract for District 10 – CICC 7360-0/08
3 with Metro Express, Inc. in an amount not to exceed \$125,000 for sidewalk and curbing repairs
4 to Metro Express, Inc. Contractor shall be required to comply with all performance bond
5 requirements, insurance requirements, and other general and special conditions as identified in
6 the invitation to bid documents.

8 **Section 2:** This resolution shall take effect immediately upon approval.
