**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL  
OF THE VILLAGE OF PALMETTO BAY, FLORIDA,  
RELATING TO NAMING OF THE MEDITATION GAZEBO AT  
CORAL REEF PARK; PROVIDING AN EFFECTIVE DATE  
[Sponsored by Mayor Eugene P. Flinn, Jr.]**

**WHEREAS**, on November 7, 2005, the Village Council adopted ordinance no 05-12 relating to naming, re-naming and co-designating village facilities, parks, etc.; and,

**WHEREAS**, pursuant to the ordinance, the village council may name a site after a person who has made a significant contribution to the community, thereby furthering the Village's good name and image; and,

**WHEREAS**, the village may recognize a person, family or corporation, that has provided a contribution through volunteerism, leadership, financial contribution and/or other services considered extraordinary or long term in nature; and,

**WHEREAS**, the Mayor and Village Council desire to adopt a name for the meditation gazebo at Coral Reef Park in honor of Kenneth Robinson. During his lifetime, Ken Robinson was a charitable man who was devoted to his family, education and community service. His family proudly watched how hard he worked to better the lives of those around him. His indefatigable and dedicated service to the incorporation efforts of the Village of Palmetto Bay helped form this outstanding community.




