RESOLUTION NO. 06-15

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA; RELATING TO PARKS AND RECREATION; AUTHORIZING THE VILLAGE MANAGER TO ENTER INTO AN AGREEMENT WITH FENCE CONNECTION, INC. FOR THE REPAIR OF DAMAGED FENCING AT CORAL REEF PARK; DISBURSING AN AMOUNT NOT TO EXCEED \$79,000; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village needs to replace fencing damaged by Hurricane Wilma at Coral Reef Park; and

WHEREAS, damage occurred to the two-rail wooden access fence that surrounds the perimeter of the park as well as the 12-foot-high tennis court fence; and

WHEREAS, specifications for fence work were sent out to various local fencing companies. Five bids were received with the lowest bidder being Fence Connection, Inc.; and

WHEREAS, we feel extremely confident that this company will provide us with quality materials and professional installation as we take another step forward in our hurricane recovery efforts; and

WHEREAS, Fence Connection has been highly recommended by the City of Homestead; and

WHEREAS, Fence Connection has been in business locally for over 20 years and they are ready to proceed with work at Coral Reef Park; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. Approve the contract with Fence Connection, Inc. for the repair of damaged fencing at Coral Reef Park.


Section 2. Disburse an amount not to exceed \$79,000.
