

RESOLUTION NO. 06-46

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO TRAFFIC ENGINEERING WITHIN THE VILLAGE OF PALMETTO BAY; AUTHORIZING THE VILLAGE MANAGER TO ENTER INTO CONTRACT WITH THE CORRADINO GROUP TO PROVIDE TRAFFIC PLANNING AND ENGINEERING SERVICES FOR THE DESIGN OF TRAFFIC FLOW ANALYSIS AND INTERSECTION IMPROVEMENTS AT US-1 AND SW 152ND STREET; AND TO APPROVE EXPENDITURE OF FUNDS IN AN AMOUNT NOT TO EXCEED \$15,000.00 ON THIS PROJECT THAT WILL IMPROVE THE SAFETY AND OPERATIONAL IMPACTS AT THIS MAJOR INTERSECTION WITHIN THE VILLAGE OF PALMETTO BAY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the intersection of US-1 and SW 152nd Street is a heavily traveled and very congested during peak traffic periods; and

WHEREAS, the goal of this project is to develop a conceptual design for access into businesses located on the south side of SW 152nd Street at the intersection of US-1; and

WHEREAS, this specific project will minimize traffic impact and ease the flow of traffic between businesses; and

WHEREAS, the Administration has determined that the Corradino Group is a very capable firm and qualified to provide traffic engineering services; and

WHEREAS, the Administration desires to select the Corradino Group to design an improved permanent traffic flow control device for the Village of Palmetto Bay


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1: Village Manager is authorized to approve expenditure of funds up to \$15,000 on a traffic engineering project that will substantially minimize traffic impact and ease the flow of traffic for businesses and their customers at the intersection of US-1 and SW 152nd Street within the Village of Palmetto Bay.

Section 2: This Resolution shall take effect immediately upon approval.
