RESOLUTION NO. 07-05

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA; RELATING TO PARKS AND RECREATION; AUTHORIZING THE VILLAGE MANAGER TO ACCEPT THE SUPPORT SERVICES FROM FRIENDS FOREVER RESCUE, INC.; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, The Village of Palmetto Bay is reaching completion of the design phase, and is about to commence the construction phase of its dog friendly park; and

WHEREAS, Friends Forever Rescue, Inc., a local non-profit organization has approached the Village about providing assistance with support functions that would contribute to the success of the much anticipated park; and

WHEREAS, Dee Chess, the organization's founder and president, is a Palmetto Bay resident who has a proven track record working with local businesses, veterinarians and volunteers to raise funds and awareness for many projects and causes relating to canines; and

WHEREAS, Friends Forever Rescue, Inc. is committed to help secure sponsorship for park equipment and coordinate yearly events to promote the park; and

WHEREAS, Friends Forever Rescue, Inc. is committed to promote the cleanliness and well being of the park, work with staff on appropriate signage and promote the park on their website; and

WHEREAS, the support from Friends Forever Rescue, Inc. will be beneficial for the success of our dog park; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. Authorize the Village Manager to accept the support services from Friends Forever Rescue, Inc. The parties shall prepare an independent contractor agreement for Friends Forever Rescue, Inc. services, which shall memorialize the terms and conditions of their independent contractor services and provide insurance information.

Section 2. This resolution shall take effect immediately upon approval.
