RESOLUTION NO. 07-102

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO THE ART-IN-PUBLIC-PLACES PROGRAM, APPOINTING MEMBERS TO THE ART-IN-PUBLIC-PLACES ADVISORY BOARD; AND, PROVIDING AN EFFECTIVE DATE.

WHEREAS, on March 5, 2007, the Village of Palmetto Bay, through adoption of Ordinance 07-05, created the Village of Palmetto Bay Art-in-Public-Places Advisory Board to provide guidance for the Art-in-Public-Places program to enhance the beauty of the Village and to generate support for community art works; and

WHEREAS, each member of the Art-in-Public-Places Advisory Board shall serve a two (2) year term and will be tasked with the duties as described in Ordinance 07-05. The Ordinance also provides for staggered terms, therefore, it is recommended three board members be appointed for two year terms, and two board members be appointed for an initial one year term. Thereafter, all board members shall serve for two year terms.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:
