3 **RESOLUTION NO. 07-113**

4 A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE
5 VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO VILLAGE
6 MANAGER; PROVIDING FOR SALARY INCREASE OF \$7,000
7 PURSUANT TO THE MANAGER'S MAY 10, 2007 EMPLOYMENT
8 AGREEMENT; PROVIDING AN EFFECTIVE DATE. (Sponsored by
9 Council person Neidhart).

10 WHEREAS, on May 10, 2007 the Mayor and Mr. Ron Williams executed an employment
11 agreement hiring Mr. Williams as the Village Manager; and,
12

13 WHEREAS, pursuant to the direction of the Mayor and Village Council, section 5.1 of
14 the employment agreement provides, that the manager shall be paid a salary of \$130,000.00 for
15 the initial term of this employment agreement (18 months), provided, however, after the initial
16 six (6) month evaluation by the council is completed, and the village council provides a favorable
17 evaluation, the village manager's salary shall be increased by \$7,000.00 for the remainder of the
18 initial term; and,

20 WHEREAS, the Mayor and Village Council desire to approve raise after the favorable six
21 month evaluation of the Village Manager.

23 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE
24 COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

26 Section 1. The above whereas clauses are incorporated into this resolution.
27

28 Section 2. Pursuant to the May 10, 2007 employment agreement the Mayor and
29 Village Council have completed their evaluation of the Village Manager and have issued a
30 favorable evaluation of him, therefore, the Village Manager, Ron E. Williams, is entitled to the
31 salary increase of \$7,000.

33 Section 3. This resolution shall take effect immediately upon approval.
