

RESOLUTION NO. 07-126

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO COUNCIL MEETING PROCEDURES; ANNOUNCING THE MEETING SCHEDULE OF THE VILLAGE COUNCIL AND OF LAND DEVELOPMENT PERMIT HEARINGS FOR THE YEAR 2008; PROVIDING AN EFFECTIVE DATE.

November 10, 2008	December 8, 2008

These hearings are tentatively scheduled to be held at Southwood Middle School, 16301 S.W. 80 Avenue, Palmetto Bay.
