RESOLUTION NO. 07-23

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA; RELATING TO PARKS AND RECREATION; APPROVING THE ENGINEERING, CONSTRUCTION, PLUMBING AND ELECTRICAL WORK TO THE BANDSHELL PAVILION AT CORAL REEF PARK AND AUTHORIZING THE FINAL UPGRADE TO THE BANDSHELL STRUCTURE IN THE AMOUNT OF \$55,300.00 THROUGH PIAZZA, INC.; AND PROVIDING AN EFFECTIVE DATE (SPONSORED BY COUNCILMAN NEIDHART.)

WHEREAS, the Council through the adoption of Resolution 07-06 unanimously approved the upgrade and enhancement of the proposed bandshell pavilion at Coral Reef Park; and,

WHEREAS, the enhancements include additional engineering, construction, electrical, and plumbing; and,

WHEREAS, the new structure has increased its covered area by 325 square feet; and expanded the types of performances that can be held; and,

WHEREAS, the ADA ramp, stairs and railings meet federal standards; and,

WHEREAS, the electrical capacity is being increased by 80% with the addition of a 100 amp service panel and electric box and electric transformer, eliminating the need for generators and extension cords; and,

WHEREAS, the plumbing will include a new water supply with three hose bib connections with integral backflow; and,

WHEREAS, the existing fence will be modified to include a removable/lockable bollard that will allow for minimized motorized vehicle access for deliveries to the east side; and,

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. The final engineering, plumbing, and electrical enhancements to the bandshell/gazebo are hereby approved in the amount of \$55,300.00 to

1 Piazza, Inc. The Village shall issue a change work order for the revised
2 plans and attach the proposed modifications to the change order.


4 Section 2. This resolution shall take effect immediately upon approval.
