RESOLUTION NO. 07-25

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO PUBLIC WORKS, AUTHORIZING THE VILLAGE MANAGER TO PROCURE A CHEVY TILT CAB WITH A DUMP LANDSCAPE BODY AND ACCESSORIES FROM MAROONE CHEVROLET, AND TO ISSUE A PURCHASE ORDER FOR SAID PURCHASE IN AN AMOUNT UP TO \$38,394.00; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, the Village of Palmetto Bay Public Works department is responsible for the maintenance of roadways, right-of-ways, tree pruning and landscaping on a daily basis; and

WHEREAS, the Village currently contracts with BFI, Inc., for a container to dispose of debris consisting of tree branches, limbs and leaves; and

WHEREAS, the expense for hauling waste is based on the volume of waste, hauling charge, and franchise charges; and

WHEREAS, the Village's Public Works Department will reduce the frequency of container pick ups by disposing of debris at Miami-Dade Solid Waste Landfills; and

WHEREAS, the Village will have the ability to chip dead palm fronds and tree branches into the dump truck for future use as mulch on landscape and beautification projects; and

WHEREAS, pursuant to the Village Purchasing Procedures, the Village may enter into contracts for services with contractors when another public agency has already followed proper formal bid procedures; and,

WHEREAS, Florida Sheriff's Association has contracted with Maroone Chevrolet for the purchase of 2007 Chevy Tilt Cab/Chassie (W3500) pursuant to its response to Bid #06-14-0821; and,

WHEREAS, the Village would like to "piggyback" on the Florida Sheriff's Association bid awarded to Maroone Chevrolet for the purchase of Chevy Tilt Cab/Chassie W3500(W3S042); and,

WHEREAS, Maroone Chevrolet has agreed to provide the necessary services to the village utilizing the same pricing, terms and conditions as set forth in the Florida Sheriff's Association Bid #06-14-0821.
