A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA; RELATING TO BOARDS AND AGENCIES; FORMING AN OLYMPIC TRIALS COMMITTEE AND APPOINTING MEMBERS THERETO (SPONSORED BY MAYOR EUGENE FLINN.)

WHEREAS, the Village of Palmetto Bay has been chosen as the site for the 2008 USA Olympic team trials for the 50K Race Walk; and

WHEREAS, this event will showcase the Village of Palmetto Bay as 60 to 70 athletes from around the country compete to realize their dreams of participating in the 2008 Olympic Games; and

WHEREAS, the Village of Palmetto Bay will team up with USA Track and Field and the Miami Dade Parks and Recreation Department to host this event in our village; and

WHEREAS, the Village wishes to create an Olympic Trials Committee and appoint ten members for purposes of reaching out to local schools, places of worship, service organizations and businesses to promote the "Village of Parks" get out and walk initiative, as well as promote the use of our walking paths/trails at our village parks; and

WHEREAS, the use of an Advisory Committee is a very effective mechanism to accomplish this objective; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:


