**RESOLUTION NO. 07-30**

**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RESPECTFULLY REQUESTING THAT THE FLORIDA LEGISLATURE CO-DESIGNATE THE PORTION OF US 1/ SOUTH DIXIE HIGHWAY WHICH FALLS WITHIN THE BOUNDARIES OF THE VILLAGE OF PALMETTO BAY, ESSENTIALLY FROM SOUTHWEST 136 STREET SOUTH TO SOUTHWEST 184<sup>TH</sup> STREET AS "PALMETTO BAY HIGHWAY"; PROVIDING AN EFFECTIVE DATE. (Sponsored by Councilman Feller)**

WHEREAS, the Village of Palmetto Bay has been a duly incorporated municipality since 2002; and,

WHEREAS, the entire westernmost boundary of the Village runs contiguous to the US 1/ South Dixie Highway; and,

WHEREAS, in recognition of the Village's incorporation, the Village Council desires to co-designate the U.S. 1 corridor encompassing the Palmetto Bay boundaries, which extend from S.W. 136th Street south to S.W. 184th Street; and,

WHEREAS, the US 1 corridor proposed for renaming was part of unincorporated Miami-Dade; and,

WHEREAS, other municipalities to the North and to the South have renamed the sections within their boundaries to provide better identification of the area; and,

WHEREAS, the US 1 / South Dixie Highway is a state road and approval from the Florida Legislature is necessary.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:


Section 1. The Council respectfully requests that the Florida Legislature co-designate the portion of US 1/ South Dixie Highway which falls within the boundaries of the Village of Palmetto Bay, essentially from Southwest 136 Street South to Southwest 184<sup>TH</sup> Street as "Palmetto Bay Highway".

2 Section 2. This resolution shall take effect immediately upon approval.


