

**RESOLUTION NO. 07 - 40**

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO GRANTS; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE AN AGREEMENT WITH MIAMI-DADE COUNTY DEPARTMENT OF HUMAN SERVICES ACCEPTING A GRANT IN THE AMOUNT OF \$3,000 FOR THE PURPOSE OF SUPPORTING SERVICES FOR THE DOMESTIC VIOLENCE PROJECT OF THE VILLAGE OF PALMETTO BAY'S POLICING UNIT; AND PROVIDING AN EFFECTIVE DATE.

**WHEREAS**, the Police Department staff has received authorization to utilize federal funds awarded from the Drug Control and System Improvement Formula Grant Program under Public Law 100-690, the Federal Anti-Drug Abuse Act of 1988; and

**WHEREAS**, under this Contract and upon award of grant funds by the State of Florida Department of Law Enforcement, Office of Criminal Justice Grants Miami-Dade County, the Village seeks to expand its support for services provided by the Domestic Violence Project; and

**WHEREAS**, the Village of Palmetto Bay Policing Unit is desirous of procuring digital cameras and removable flash drives in an effort to assist with the reduction of Domestic Violence, as noted in the Program Narrative (Attachment A of the Contract).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

**Section 1.** The Village Manager is authorized to accept this grant and execute an agreement for the provision of these services in order to procure Domestic Violence assistance and prevention equipment utilizing the funds awarded from the Drug Control and System Improvement Formula Grant Program under Public Law 100-690, the Federal Anti-Drug Abuse Act of 1988.

**Section 2.** This resolution shall take effect immediately upon approval.
