4 A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE
5 VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO THE
6 BISCAYNE BAY COASTAL WETLANDS ACCERLER8 PROJECT AT
7 THE DEERING ESTATE; EXPRESSING STRONG SUPPORT FOR THE
8 FULL FUNDING AND COMPLETION OF THE 3 ACRE WETLANDS
9 ENVIRONMENTAL EDUCATIONAL PROJECT ON THE POWERS
10 PROPERTY; PROVIDING AN EFFECTIVE DATE. (Sponsored by
11 Mayor Flinn)

14 WHEREAS, the Village of Palmetto Bay, the South Florida Water Management
15 District, Miami-Dade County and the Deering Estate have cooperatively and
16 collaboratively worked together on a number of important projects essential to the
17 Everglades and Biscayne Bay preservation and restoration; and

19 WHEREAS, the Accerler8 rehydration project linking the C-100 canal to
20 Biscayne Bay through the Village of Palmetto Bay, Deering Estate and Powers Property
21 is an excellent example of this multi-agency cooperation; and

23 WHEREAS, this project has included a 3 Acre Wetlands Environmental
24 Education Center; and

26 WHEREAS, the 3 Acre Wetlands Environmental Education Center is a major
27 feature beneficial to the community and a vital and essential component of this project
28 that is central to the strong public support that the project has developed;

30 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE
31 COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

33 Section 1. The Village of Palmetto Bay expresses strong support for the full
34 funding and completion of the 3 Acre Wetlands Environmental Education Project as an
35 essential component of the Acceler8 Project at the Deering Estate.

37 Section 2. This resolution shall take effect immediately upon approval.


