RESOLUTION NO. 07-77

A RESOLUTION OF THE MAYOR AND THE VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, REQUESTING THAT THE FLORIDA LEAGUE OF CITIES ADOPT A RESOLUTION SUPPORTING HOUSE BILL 7167 WHICH WAS APPROVED BY THE GOVERNOR AND FOR THE FLORIDA LEAGUE OF CITIES TO FURTHER REQUEST THAT MIAMI-DADE COUNTY ABIDE BY THE LEGISLATION; PROVIDING FOR AN EFFECTIVE DATE

13 **WHEREAS**, on May 4, 2007, Governor Crist signed into law House Bill 7167 which prohibits
14 any municipality formed after January 1, 2000 from being required to pay any charge, assessment, tax,
15 fee or other consideration as a condition for allowing its citizens to incorporate and govern themselves;
16 and

17 **WHEREAS**, the Village of Palmetto Bay believes that it is in the best interests for citizens
18 throughout the state to be allowed to incorporate without having to pay such a fee or mitigation; and

19 **WHEREAS**, because of the significant public policy and benefit to citizens throughout the
20 state, the Village Council of the Village of Palmetto Bay formally requests that the Florida League of
21 Cities adopt a Resolution supporting the legislation and for the Resolution to further request that
22 Miami-Dade County abide by the new legislation.

23 **NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF
24 VILLAGE OF PALMETTO BAY, FLORIDA THAT:**

25 Section 1. The foregoing "WHEREAS" clauses are ratified and confirmed as being true and
26 correct and are made a part of this Resolution upon adoption.

27 Section 2. The Village Council of the Village of Palmetto Bay, Florida formally requests that
28 the Florida League of Cities adopt a Resolution supporting the new law which prevents governmental
29 entities from charging a tax, fee or mitigation as a condition for allowing citizens to incorporate and
further requests that Miami-Dade County abide by the new legislation.

1 Section 3. The Village Clerk is hereby authorized to transmit a copy of this Resolution to the
2 Florida League of Cities, Inc., the Governor, the Speaker of the House of Representatives, the
3 President of the Senate, and representatives and senators that represent Miami-Dade County.

4 Section 4. This resolution shall become effective upon its passage and adoption by the
5 Mayor and Village Council.


