4 A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE
5 VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO AD
6 VALOREM TAXES; DETERMINING THE PROPOSED MAXIMUM
7 MILLAGE RATE AND SETTING THE DATES, TIME AND LOCATION
8 FOR THE FIRST AND SECOND BUDGET HEARINGS FOR FY 07-08;
9 DIRECTING THE VILLAGE CLERK TO FILE SAID RESOLUTION
10 WITH THE MIAMI-DADE COUNTY PROPERTY APPRAISER; AND
11 PROVIDING FOR AN EFFECTIVE DATE.

12 WHEREAS, the Village has received the Certification of Taxable Value from the Miami-
13 Dade County Property Appraiser; and,

14 WHEREAS, the Village is required under State Statutes to establish and furnish to the
15 Property Appraiser the proposed maximum millage rate and the dates, times and location(s) at
16 which public hearings will be held to consider the FY 07-08 millage rate and budget;

18 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE
19 COUNCIL OF THE VILLAGE OF PLAMETTO BAY, FLORIDA, AS FOLLOWS:

20 Section 1. The proposed maximum millage rate for the Village of Palmetto Bay for
21 FY 07-08 is established at 2.3736 mills, which is \$2.3736 for each \$1,000.00 of assessed property
22 within the Village of Palmetto Bay.

23 Section 2. The rollback millage rate is 2.1443 mills.

24 Section 3. The proposed date and place of the first and second public hearings are
25 scheduled as follows:






