4 A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE
5 VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO MIAMI-
6 DADE COUNTY SUPPORTING COUNTY EFFORTS FOR STATE
7 FUNDING ASSISTANCE FOR AND REQUESTING COUNTY
8 FUNDING TO COMPLETE THE PLANNED RENOVATIONS TO THE
9 C-100 PARK DURING THE 2008-2009 FISCAL YEAR; TO COMPLETE
10 THE PARKING LOT, LIGHTING, AND CANOE LAUNCH AREA;
11 PROVIDING AN EFFECTIVE DATE (Sponsored by Mayor Eugene P.
12 Flinn, Jr).

15 WHEREAS, the Mayor and Village Council support the Miami-Dade County Board of
16 County Commissioners and the Miami-Dade Parks Department in its efforts to improve and
17 renovate parks and, specific in this case to C100, to promote public access to beautiful Biscayne Bay
18 both in shoreline as well as green activities such as canoes and kayaks; and,

20 WHEREAS, the Mayor and Village Council have partnered with Miami-Dade County in
21 improving Ludovici Park and the Palmetto Bay Library on Old Cutler Road; and,

23 WHEREAS, Palmetto Bay, the "Village of Parks," had expended funds over the years to
24 purchase park land, including the Thalatta Historic Structure and associated 4 acres of land adjacent
25 to the County's C-100 park; and,

27 WHEREAS, the County supports the use of the Blue Way, water trails for recreational uses
28 and existing County plans to re-develop a canoe/kayak launch at C-100 park; and,

30 WHEREAS, the C-100 park is also adjacent to the Old Cutler Bike Path and could be
31 developed as park of the County's Green Ways bike development program; and,

33 WHEREAS, the Mayor and Village Council petitions the Board of County Commissioners
34 to complete the renovations to the C-100 park, including the parking lot, lighting and canoe/kayak
35 launch areas of the park within the 2008-2009 fiscal year.


41 Section 1. The above whereas clauses are incorporated by reference herein.

45 Board of County Commissioners.


