RESOLUTION NO. 09-29

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO CONTRACTS; APPROVING THE SELECTION OF VALLEYCREST LANDSCAPE MANITENANCE TO PROVIDE PARKS LANDSCAPE MAINTENANCE SERVICES, INCLUDING MAINTENANCE OF ATHLETIC FIELDS, FOR VILLAGE PARKS PURSUANT TO BID NO. 2009-PR-001; APPROVING A CONTRACT WITH SAID FIRM FOR AN INITIAL THREE-YEAR TERM, AND A ONE-YEAR EXTENSION OPTION; AUTHORIZING THE VILLAGE MANAGER TO ISSUE A PURCHASE ORDER NOT TO EXCEED \$82,665; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of Palmetto Bay parks are thriving with attendance; and,

WHEREAS, the Village requires the assistance of a vendor to provide park common area and athletic field maintenance services; and,

WHEREAS, the current vendor contract has expired and in compliance with the Village's procurement policies, the Village, on February 6, 2009, issued an Invitation to Bid under Bid number 2009-PR-001; and,

WHEREAS, the Village desires to select the most responsive bidder to provide services as delineated in the invitation to bid; and,

WHEREAS, ValleyCrest Landscape Maintenance was determined to be the most responsive proposed vendor; and

WHEREAS, the parties desire to enter into an agreement for parks common areas and athletic fields maintenance services in compliance with the terms of the invitation to bid under bid number 2009-PR-001 with ValleyCrest Landscape Maintenance; and,

WHEREAS, the proposed contract for services is for a three year period, and contains a one-year option to renew; and,

WHEREAS, the Mayor and Village Council desire to approve a contract with ValleyCrest Landscape Maintenance; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. The Village Council hereby approves the selection of Valley Crest Landscape Maintenance to provide maintenance services for the grounds and athletic fields at Village park facilities pursuant to Bid No. 2009-PR-001.

1 **Section 2.** The contract between the Village of Palmetto Bay and Valley Crest
2 Landscape Maintenance, providing for an initial three-year term with a one-year extension option,
3 and which is attached hereto as Exhibit 1, is hereby approved.

5 **Section 3.** The Village Manager is hereby authorized to issue a purchase order not to
6 exceed \$82,665.

8 **Section 4.** This resolution shall take effect immediately upon adoption
