RESOLUTION NO. 2010-12

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO TRANSIT CIRCULATOR SERVICES; AUTHORIZING LIMOUSINES OF SOUTH FLORIDA, INC. TO CONTINUE PROVIDING TRANSIT CIRCULATOR SERVICES; FURTHER AUTHORIZING THE VILLAGE MANAGER TO ISSUE A PURCHASE ORDER IN AN AMOUNT NOT TO EXCEED \$50,000.00; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village transportation shuttle bus (IBUS), began its regularly scheduled routes on August 9, 2006; and,

WHEREAS, currently, Limousines of South Florida, Inc. provides bus services within the boundaries of the Village according to the Village's approved scheduled bus route; and,

WHEREAS, the Village entered into an agreement with Limousines of South Florida, Inc. on March 6, 2006 for municipal bus services; and,

WHEREAS, The Department of Public Works has contacted Limousines of South Florida, Inc. and received authorization to continue to "piggy back" onto the Amended Bal Harbour Village Contract to provide continued transit circulator services; and,

WHEREAS, the Administration is requesting authorization to continue utilizing Limousines of South Florida, Inc. for transit circulator services through June 30, 2010 as per amended contract with Bal Harbour Village; and,

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1: The Village Manager is authorized to continue the agreement with Limousines of South Florida regarding Transit Circulator Services; in an amount not to exceed \$50,000.

Section 2: This resolution shall take effect immediately upon approval.
