RESOLUTION NO. 2010- 26

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO PARKS AND RECREATION; EXPRESSING SUPPORT FOR INSTALLATION AND MAINTENANCE OF WIRELESS LOCAL AREA NETWORK ACCESS POINTS (WIFI) AT CORAL REEF PARK AND PALMETTO BAY PARK; PROVIDING AN EFFECTIVE DATE. (Sponsored by Mayor Eugene P. Flinn, Jr.)

**WHEREAS**, during the establishment of the Parks Master Plans, Mayor Flinn suggested that the Village install Wireless Local Area Network Access Point (WIFI) at Coral Reef Park and Palmetto Bay Park. Said WIFI was installed; however, during recent tropical storm activities, WIFI capability has been intermittent; and,

**WHEREAS**, programming continues to improve at both Coral Reef and Palmetto Bay Park and with the installation of a concessionaire at both parks, the ability of visitors to be able to bring their laptops and be connected while they enjoy a refreshment in the outdoors is desirable; and,

**WHEREAS**, the Village Council would like to express their support for the provision of this amenity.

**NOW THEREFORE BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA;**

**Section 1.** The above whereas clauses are incorporated by reference.

**Section 2.** The Village Manager is directed to investigate the current configuration of the WIFI points at the Parks, determine if repair or new installation is necessary, and instruct the repair or new installation to be performed.

**Section 3.** This resolution shall take effect immediately upon approval.
