A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, SUPPORTING MIAMI-DADE WATER & SEWER DEPARTMENT'S BASIN B AND C CONSTRUCTION FOR WATER AND SEWER IMPROVEMENTS WITHIN THE VILLAGE OF PALMETTO BAY; PROVIDING AN EFFECTIVE DATE. [Sponsored by Mayor Eugene P. Flinn, Jr.].

WHEREAS, in an effort to improve infrastructure in order to respond to population growth and in an effort to facilitate economic development, the Miami-Dade County Water & Sewer Department has targeted areas within Palmetto Bay, known as Basin B and Basin C, for significant water and sewer construction projects; and

WHEREAS, the Village of Palmetto Bay recognizes and appreciates the planning and future construction of these outstanding projects, as they will directly benefit the Village residents and businesses by installing new water and sewer infrastructure to provide much-needed fire protection and efficient flow, which will also support economic development; and

WHEREAS, the Mayor and Village Council finds that this Resolution is in the best interest and welfare of the residents of the Village of Palmetto Bay, and all of Miami-Dade County, Florida.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:


