

RESOLUTION NO. 2010-41

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO THE NAMING OF A TRAFFIC CALMING DEVICE LOCATED AT SW 160 STREET AND SW 82 AVENUE, AS THE "PAUL NEIDHART TRAFFIC CIRCLE" IN HONOR OF THE FIRST ELECTED VILLAGE OFFICIAL AND FORMER TWO-TERM COUNCIL MEMBER PAUL NEIDHART; AND RECOGNIZING HIS SIGNIFICANT CONTRIBUTIONS TO ROADWAY AND TRAFFIC IMPROVEMENTS WITHIN THE VILLAGE; PROVIDING FOR AN EFFECTIVE DATE. WHEREAS, Paul Neidhart was the first official Council person of the Village of Palmetto Bay, and

WHEREAS, he was unopposed in the initial election, thus, he became the first Councilmember representing District 2 , being elected in September of 2002, , and

WHEREAS, for many years, Mr. Neidhart was the owner/operator of Curbside Florist, a household name in this community, and

WHEREAS, Mr. Neidhart is known for his charitable works, civic activism, and community service and has been active for many years in many charitable organizations, and

WHEREAS, Mr. Neidhart was instrumental in initiating a number of projects throughout the Village during his tenure as Councilmember; and

WHEREAS, it is the desire of the Mayor and Village Council to name the traffic calming device located at SW 160 Street and SW 82 Avenue, "Paul Neidhart Traffic Circle", formerly identified as the "First Traffic Circle" in the Village in honor of Paul Neidhart for his significant contributions to infrastructure, roadway and traffic improvements within the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. The Village Council hereby approves that the traffic calming device located at SW 160 Street and SW 82 Avenue be named "Paul Neidhart Traffic Circle" in honor of the Village's first elected Council person, Paul Neidhart.
