RESOLUTION NO. 2010-42

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, CO-DESIGNATING S.W. 168 STREET FROM OLD CUTLER ROAD EAST TO SW 72 AVENUE AS "DEERING ESTATE WAY"; PROVIDING AN EFFECTIVE DATE. (Sponsored by Councilman Howard J. Tendrich)

WHEREAS, on November 7, 2005, the Village Council adopted Ordinance 05-12 that established procedures for naming of roadways and facilities; and

WHEREAS, the portion of SW 168 Street from Old Cutler Road east to SW 72 Avenue remains a Village-owned and maintained roadway; and

WHEREAS, in the early 1900's, Charles Deering decided that he would relocate from Chicago to South Florida and would become of our areas earliest pioneers. The Deering Estate is well-known throughout the world as one of the finest examples of Mediterranean architecture in South Florida and for its outstanding collection of antiques and artifacts; and

WHEREAS, Palmetto Bay remains proud of the cultural events, recreation activity, and beautiful views that the Deering Estate at Cutler provides to our community.

WHEREAS, the Village of Palmetto Bay is desirous of naming SW 168 Street from Old Cutler Road east to SW 72 Avenue in honor of the Deering Estate at Cutler and gives instruction to the Village Manager with regard to carrying out this directive.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. Southwest 168 Street between Old Cutler Road east to SW 72 Avenue shall be named **DEERING ESTATE WAY**.

Section 2. The Village Manager is instructed to install appropriate markers recognizing the co-designation of this roadway.

Section 3. This resolution shall take effect immediately upon approval.


