

RESOLUTION NO. 2010-44

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO PARKS AND RECREATION; AUTHORIZING THE VILLAGE MANAGER TO INITIATE AND COMPLETE APPROPRIATE STEPS AS MAY BE NECESSARY TO EFFECTUATE COMPLIANCE IN THE APPLICATION FOR THE DESIGNATION OF PLAYFUL CITY USA; DESIGNATING ANNUAL 'PLAY DAYS', AND FURTHER AUTHORIZING THE VILLAGE MANAGER TO APPROVE EXECUTION OF PROGRAM COMMITMENTS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Playful City USA Program, as sponsored by the KaBOOM! Organization, is a national recognition program that since 1996 has been honoring cities and towns across the nation for the creation of an agenda for play; and

WHEREAS, qualifying commitments for the Program include 1) the creation of a Local Play Commission Task Force, 2) design of an annual 'Action Plan for Play', 3) completion of a Playspace Audit of all publicly accessible play areas, 4) identification of the current capital expenditure budget and maintenance of play spaces, and 5) proclamation and celebration of an annual 'Play Day'; and

WHEREAS, the Village of Palmetto Bay, appropriately deemed the 'Village of Parks', is known for its beautiful parks and commitment in providing wholesome recreational opportunities for youth; and

WHEREAS, the Village of Palmetto Bay desires to obtain the Playful City USA designation and be so recognized on a national level.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. The Village Manager and/or appointed designee is hereby authorized to submit application form and execute appropriate documents on behalf of the Village of Palmetto Bay in pursuit of the designation of Playful City USA, as sponsored by KaBOOM!


Section 2. The Village Manager and/or appointed designee are hereby authorized to establish and facilitate a Local Play Commission Task Force.

Section 3. The officially proclaimed annual 'Play Day' shall be the date of the Village's Annual Picnic, with programming to be expanded accordingly. Additional activities, such as the 'End of the Summer Camp Bash', may be incorporated as a 'Play Day' celebration as deemed appropriate and approved by the Village Manager.

Section 4. This resolution shall take effect immediately upon adoption
