**RESOLUTION NO. 2012-35**

**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO BOARDS AND AGENCIES; ACCEPTING THE JOINT REPORT OF THE BUILDING AND PERMITTING ADVISORY COMMITTEES; PREPARED BY THE RESIDENTIAL PERMITTING SUBCOMMITTEE AND COMMERCIAL PERMITTING SUBCOMMITTEE; AND PROVIDING AN EFFECTIVE DATE. [Sponsored by Mayor Shelley Stanczyk]**

**WHEREAS**, the Mayor and Village Council pursuant to section 2-46 of the Village's Code of Ordinances created the Residential and Commercial Permitting subcommittees, which together encompass the "Building and Permitting Advisory Committee"; and

**WHEREAS**, the Joint Committee reviewed the permitting process of the Village; and,

**WHEREAS**, the scope of the Committee was to review the building and permitting process and included a review of the zoning procedures and/or codes affiliated with the building process; and,

**WHEREAS**, the Committee prepared a report with the input from the two (2) subcommittees (Residential and Commercial permitting Subcommittees) and produced the report to the Village Council; and,

**WHEREAS**, the Committee was incredibly diligent in meeting for eight (8) months, accepting and identifying such a serious task, and issuing recommendations that include a simplified fee schedule, updated customer review process, additional information products, and greater internet access and more and upon review and examination of budgetary and process impacts, will make positive constructive changes for residents and business owners; and,

**WHEREAS**, the Mayor and Village Council desire to accept the report of the Committee; and,

**WHEREAS**, the Permitting Advisory Committee has sunsetted; and,

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:**
