WHEREAS, the amounts are reasonable and were necessarily incurred.



Section 1. The statements for attorneys' fees and costs received from WHITE & CASE, in the total amount of \$10,508.72, copies of which are attached, are approved for payment.


Section 2. This resolution shall take effect immediately upon approval.
