RESOLUTION NO. 2012-90

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO OFFICE EQUIPMENT; AUTHORIZING THE VILLAGE MANAGER TO ENTER INTO A 36-MONTH LEASE AGREEMENT WITH RICOH FOR TWO PHOTOCOPIERS AT A COST OF \$314 MONTHLY FROM RICOH, USA, INC., THROUGH MIAMI-DADE COUNTY CONTRACT; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Village of Palmetto Bay hereby determines that a need exists for the replacement of two Ricoh MP6000 multifunction photocopiers via a lease agreement for the Village's Building Department and the Village's Policing Unit; and

WHEREAS, the Village Manager is seeking approval for the lease renewal and delivery of the replacement of Ricoh MP6000 photocopier machines, as attached in Exhibit "A"; and

WHEREAS, the current lease with Ricoh, USA, Inc., expires in December of 2012; and

WHEREAS, Ricoh has proposed to replace the current MP6000 photocopier machines with a new model MP4002 for \$314.00 per month, resulting in a significant cost savings to the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:


Section 1. The Village Manager is authorized to enter into a 36-month lease agreement with Ricoh, USA, Inc., in the amount of \$314.00 per month.


Section 2. The above recitals are true and correct and are incorporated herein by this reference.


