4 **A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE**
5 **VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO SUPPORT**
6 **GOVERNOR RICK SCOTT'S INITIATIVE TO INCREASE PUBLIC**
7 **SCHOOL TEACHERS' SALARIES; PROVIDING AN EFFECTIVE DATE.**

8 WHEREAS, the Mayor and Village Council support Governor Scott's initiative to increase
9 teachers' salaries by \$2500 with the purpose of attracting and retaining high quality teacher to
10 Florida's public schools which is a priority for Palmetto Bay, Miami-Dade County and the state at
11 large; and,

13 WHEREAS, the initiative is a necessary first step in raising the salaries of public school
14 teachers to the national average; and,

15
16 WHEREAS, the Mayor and Village Council also support the segregation of the funds to be
17 allocated for this purpose to ensure the payments to the teachers; and,

19 WHEREAS, the Governor's initiative to provide the \$2,500 per public school teacher salary
20 increase would be available to all full-time K-12 public school classroom teachers, as defined in
21 Section 1012.01(2)(a), Florida Statutes; and,

23 WHEREAS, all full-time prekindergarten classroom teachers funded through the Florida
24 Education Finance Program would be eligible for the salary increase; and,

26 WHEREAS, the United Teachers of Dade also support Governor Scott's initiative; and,

28 WHEREAS, the Mayor and Village Council desire to support the Governor's initiative as it
29 relates to supporting a pay increase for public school teachers.

31 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE
32 COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

34 Section 1. The foregoing "Whereas" clauses are hereby ratified as true and correct and
35 are incorporated herein by this reference.

37 Section 2. The Village Clerk is authorized on behalf of the Village to provide executed
38 copies of this resolution to the Village's lobbyist, and to the Florida Legislature, the Mayor of
39 Miami-Dade County, each member of the Miami-Dade Board of County Commissioners, as well as
40 each municipal clerk in Miami-Dade County for the purpose of distributing copies to members of
41 their respective governing councils.

43 Section 3. This resolution shall be effective immediately upon its adoption.


